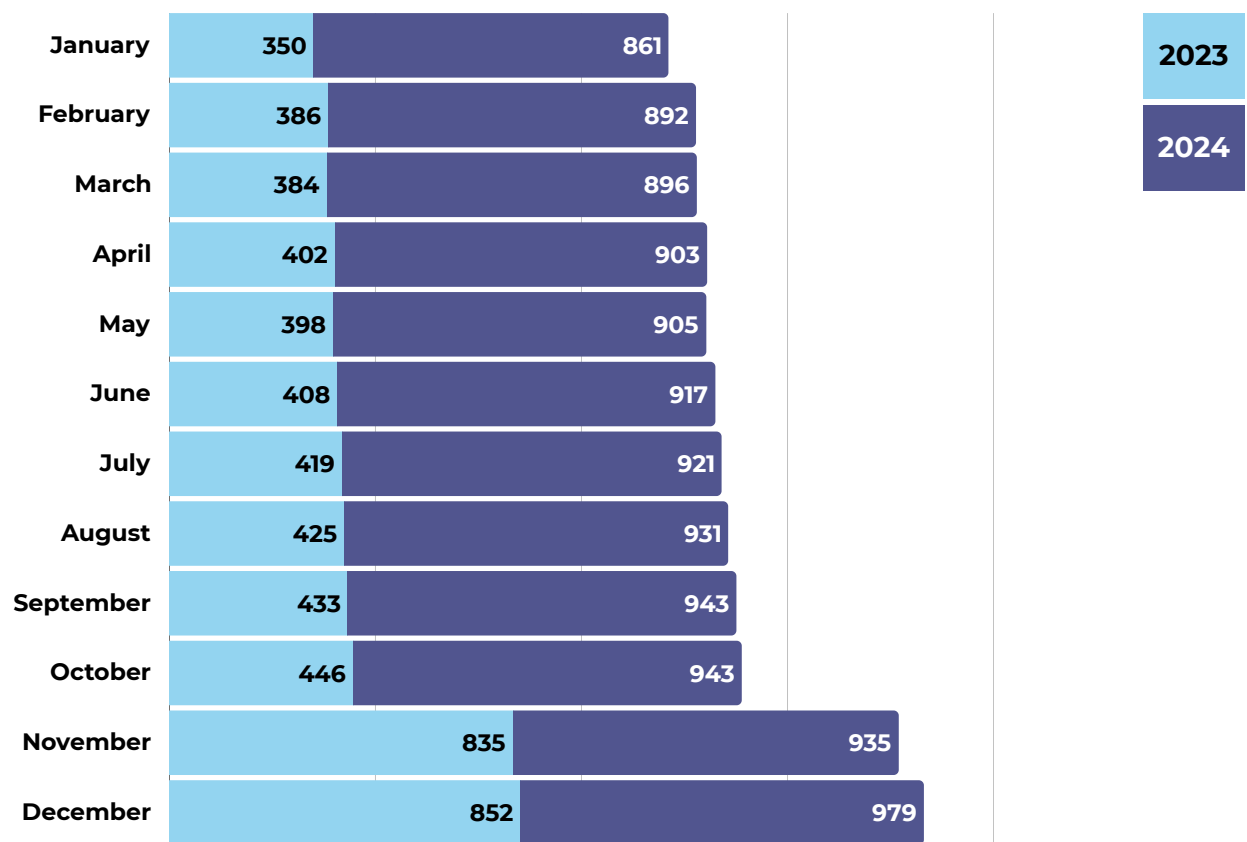


COMMUNICATIONS HIGHLIGHTS

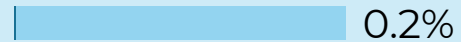

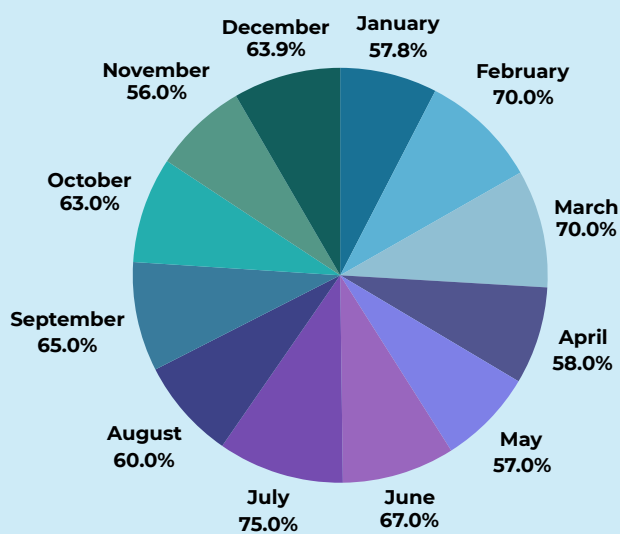
Average Successful Deliveries



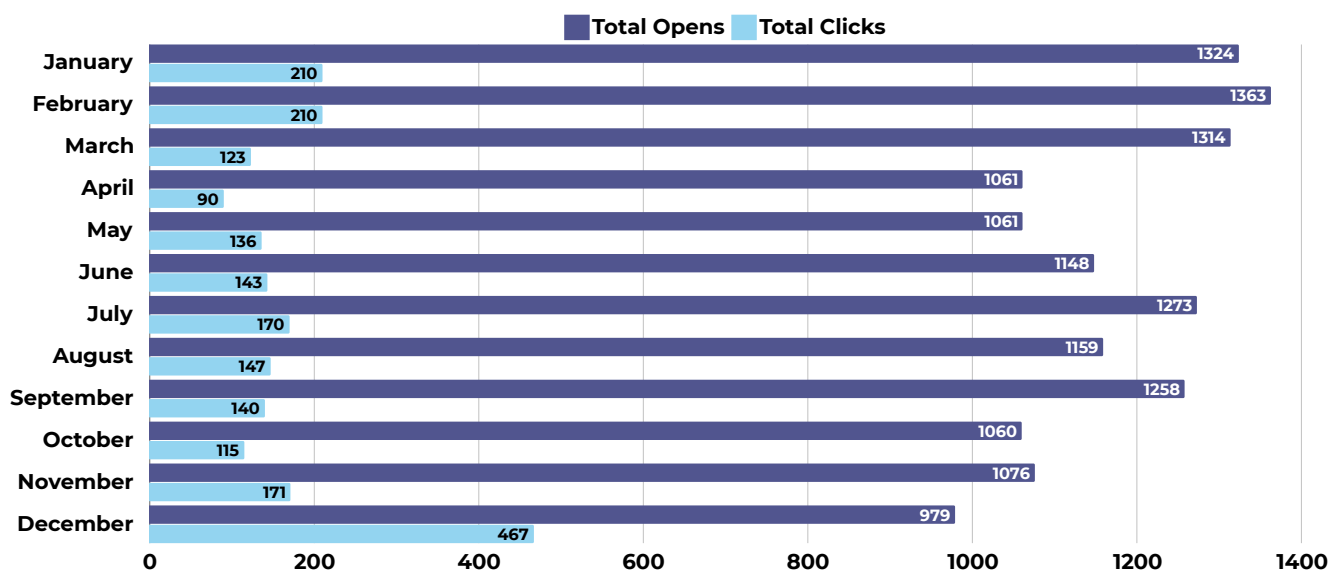
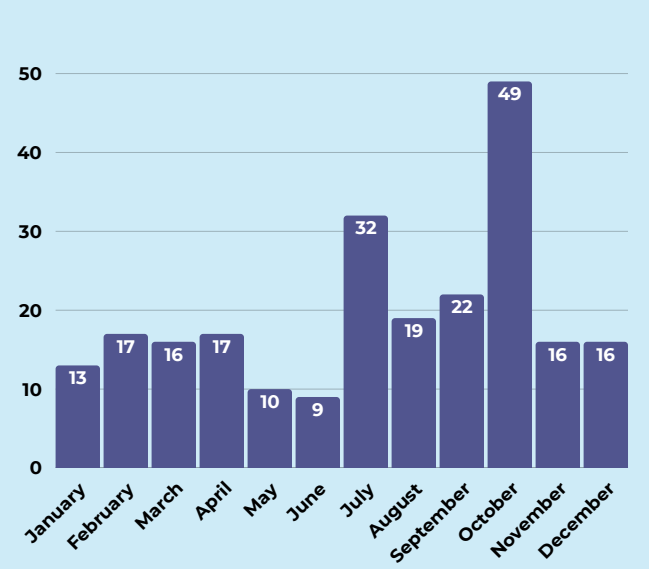
Average Unsubscribe Rate

DIGITAL HEALTH UPDATES

Online Appointment Booking

KW4 OHT received funding approval from Ontario Health for the Online Appointment Booking (OAB) initiative for fiscal year 2024-2025. The KW4 OHT OAB proposal includes 20 primary care sites across the OHT, representing 110 providers from last fiscal year that requested funding to support the ongoing use of online appointment booking. Additionally, 41 new licenses were requested and will allow more providers to offer online access for for patients to book appointments.

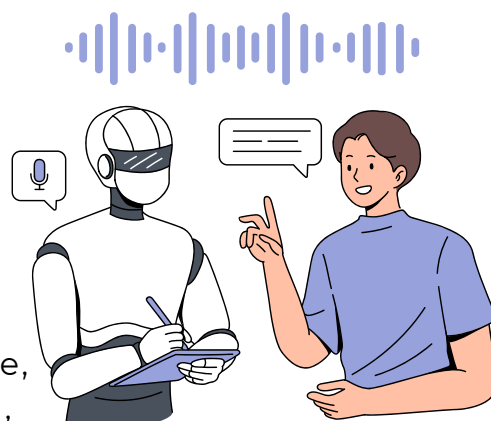


The continued implementation of OAB will advance the KW4 OHT and primary care goals by transforming how care is delivered, making more health services accessible online, and enabling patients to plan their access to participating health services at their convenience. This funding will enable primary care organizations in KW4 to expand OAB implementation within primary care settings, thereby supporting access to care for the patients they serve.

AI Scribe

Curious about how AI can benefit your clinical practice?

Join the Health Care Unburdened Grant program. Ambient scribe technology supports care clinics by transcribing patient-clinician conversations in real-time, enhancing medical record documentation, and potentially saving you up to 50% on your charting time. Funded by Scotiabank in collaboration with the Canadian Medical Association (CMA) and MD Financial Management Inc. (MD), the Department of Family and Community Medicine, University of Toronto and KW4 OHT will support family practices in adopting Ambient Scribe technology as part of the Health Care Unburdened Grant (HCUG) program. HEALTH SYSTEM UPDATES

HART HUB

We are delighted to share this announcement on behalf of Tara Groves-Taylor, Community Healthcaring Kitchener-Waterloo, and John Neufeld, House of Friendship.

They were notified on January 2, 2025 by the Ontario Government that the Region of Waterloo HART Hub application submitted for the transition from CTS in March 31, 2025 has been one of the initial approved submissions in Ontario.

“ So far, what we know is that we have been granted the funding allotment for the 3 year pilot, and that it is expected that we will begin implementation of a transition plan with our partners at the Region and Sanguen in the coming months, in order to have the HART Hub operational by March 31, 2025.

We are encouraged by this funding coming into our community given the needs of those that we serve. We will endeavor to do our best to support community members affected by the CTS closure.

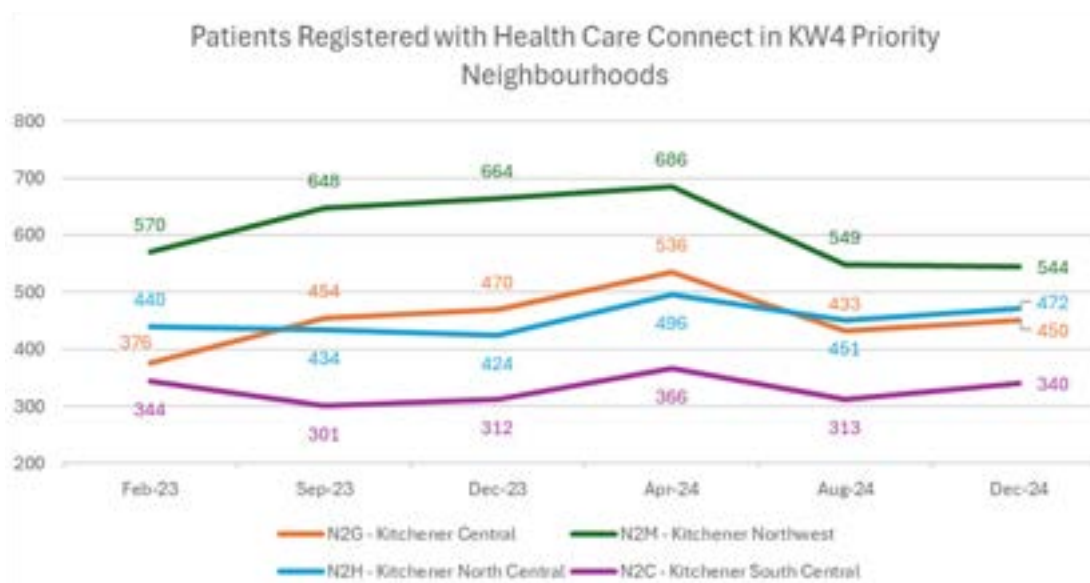
PROGRESS AND RESULTS

HEALTH CARE CONNECT REGISTRATION

As of December 12, 2024, 2024, there were 5,795 people in KW4 registered with Health Care Connect to find a primary care provider. This has increased slightly from August 2024 (5,719). Although two doctors started new practices in Waterloo since Nov 18, 2024, more patients have registered with Health Care Connect than have been removed from the list.



We continue to see our priority neighbourhoods being disproportionately impacted. These four neighbourhoods make up 18% of our population yet represent 31% of those registered.



The KW4 OHT staff continue to work with HCC to identify more ways to connect community members to primary care.
