



ONTARIO APPROVES HART HUB TRANSITION IN WATERLOO REGION

Tara Groves-Taylor, Community Healthcaring Kitchener-Waterloo and John Neufeld, House of Friendship are pleased to share that the Region of Waterloo HART Hub application has been approved. The application was submitted in response to the Ontario Government's plan to transition to HART Hubs from Consumption and Treatment Services (CTS) as implementation of a transition plan with partners at the Region, Sanguen and Langs Community Health Centre to ensure the HART Hub is operational by March 31, 2025.

As HART hub co-leads, Community Healthcaring Kitchener-Waterloo and the House of Friendship, will be working closely with community partners across the Waterloo Region to build on a collaborative network to support vulnerable people in our community.

BLACK HEALTH ACTION PLAN

SEAMLESS CARE OPTIMIZING PATIENT EXPERIENCE (SCOPE) EXPANSION

We are pleased to share that St. Mary's General Hospital was successful in their application to expand SCOPE services as part of the Black Health Plan outlined in the ["A Black Health Plan for Ontario – A Call to Action to Reduce Disparities and Advance Equity in Ontario."](#)



This multi-year funding will allow for the provision of locally informed, culturally responsive interventions and clinical care to advance access to healthcare services for individuals identifying as members of the black community.

This initiative will support primary care providers facilitating navigation to various resources, for example improved access to diagnostic tests, health and wellness clinics, and mental health and addictions services. This initiative will also help to identify gaps in services and care specifically experienced by the black community including francophone and newcomers in priority areas. This information will inform strategies and solutions for implementation.

SCOPE has been in place in the KW4 area since April 2022 and demonstrated success in engaging primary care providers who work with marginalized communities to provide access to resources and care. SCOPE has also successfully engaged specialists to improve access and support for patients who do not have a primary care provider. This funding acknowledges the great work already provided through the SCOPE program.

PEDIATRIC RECOVERY FUND

MENTAL HEALTH SUPPORTS FOR BLACK CHILDREN AND YOUTH - COMMUNITY HEALTHCARING KW

We are pleased to share that Community Healthcaring KW was successful in their application to the Pediatric Recovery Fund – for the proposed initiative – “Mental Health Supports for Black Children and Youth” through Ontario Health in response to a call for applications for Initiatives that support Black children and youth facing mental health challenges.

This funding will facilitate increased access to Community Healthcaring Kitchener-Waterloo’s community-based mental health/outreach supports, counselling services, youth/children’s groups, crisis response, and service navigation. By partnering with local hospitals, school boards, mental health and addiction providers, and other community organizations that serve this population, the CHC will foster relationships to improve health equity in a culturally responsive and sensitive manner.

ONLINE APPOINTMENT BOOKING

In January, participating online appointment booking (OAB) primary care sites submitted Quarter 1-Quarter 3 activity reports, a key deliverable for the Ontario Health Funding. Below are highlights of these metrics:

80%*

of our target has been achieved for the number of primary care providers actively using OAB.




We have exceeded our target of new primary care providers using OAB for the first time by

of our target has been achieved for the number of patients that have access to OAB through their primary care provider.

22,435*

appointments were completed, all self-scheduled by the patient using the OAB solution between April – December.

PROGRESS AND RESULTS

QUARTERLY PERFORMANCE REPORT

As part of KW4's September 2020 application to become an OHT, we were required to describe how our team will measure and monitor our success. Members endorsed the measures shown in the snapshot of our performance below, which we now report on quarterly.

KW4 OHT is performing at or better than the targets we have set for two of our performance measures including caregiver distress among home care clients and alternate level of care (ALC) days.

KW4 OHT is not meeting the target set for two of our performance measures including hospitalization for ambulatory care sensitive conditions and frequent emergency room visits for mental health and addictions.
